Approval is restricted to those entries meeting the guidelines. The Parks and Recreation and Parade Committee reserve the right to remove/deny any entry that does not meet the established standards. Parade entrants must provide their own signage. **This will be strictly enforced.**

Understanding that participation in the Holiday Lights Parade is completely voluntary, I, the undersigned, agree to hold harmless the City of Beaumont in the unlikely event of any accident or occurrence which causes or may cause damage or harm to yourself and/or your property and that of any others who participate as a part of your group or organization and those who may be participating in a support role of your organization and those who may be taking direction from yourself or other members of your group or organization. I also affirm and understand that no one may ride on top of or outside the confines of any vehicle participating in the parade and that at no time will items (candy, trinkets etc.) be thrown from any vehicle to any parade spectators.
