


# CANDIDACY IN A MUNICIPAL ELECTION

Your guide to a City of Beaumont Municipal Election



## **ELECTION DATE:**

Beaumont will conduct a General Municipal Election on **Tuesday, November 5, 2024**.

The election is held on the same day as the statewide General Election

## **POSITIONS AVAILABLE FOR THE 2024 ELECTION:**

- Two (2) City Council Member Seats

## **QUALIFICATIONS FOR OFFICE:**

- U.S. citizen
- 18 years or older
- Registered voter living in the city of Beaumont

*The following information is intended to assist residents who are considering running for public office.*

## **CANDIDATE FILING PERIOD**

The filing period begins on July 15, 2024 and ends on August 9, 2024. If an incumbent does not file by August 9, the filing period shall be extended to 5:00 p.m. on August 14, 2024 for candidates other than the incumbent.

A Candidate's Handbook, including an Official Nomination Paper, Candidate's Statement Form, Fair Political Practices Commission (FPPC) Form 700 and Campaign Disclosure Forms, and other information concerning the election will be available by appointment at the City Clerk's Office beginning July 15, 2024.

## GENERAL INFORMATION

The City of Beaumont incorporated on November 18, 1912 as a General Law city, with a Council-Manager form of government. The Beaumont City Council is comprised of five Council members, each sharing equal voting powers on all items coming before the Council.

Council members, City Clerk and City Treasurer are elected to at-large positions for four-year terms, with elections held in November of even-numbered years. The City Council meets annually to select one of its members to serve as Mayor and another to serve as Mayor Pro Tem for one year but no more than two consecutive years.

## COUNCIL MEETINGS

City Council Meetings are held on the **first and third Tuesday of the month at 6:00 p.m.** in the City of Beaumont Council Chambers, 550 E. 6th Street, unless otherwise noticed. The official posting area for all meeting agendas is located on the bulletin board outside the Civic Center. ## SALARY FOR ELECTED OFFICIALS

Each Council Member will receive a monthly salary of \$1,600.00.

## POLITICAL SIGNS

Political sign in the public right-of-way require an encroachment permit prior to placement of signs. Please contact the Public Works Department to obtain a permit and copy of the sign regulations.
